TERMS AND CONDITIONS

Both parents / guardians are responsible for the payment of school fees.

Parents may apply for full or partial exemption of school fees in terms of Section 39 of the South African Schools Act if they are financially unable to meet the obligation. Exemptions are granted in accordance with an approved schedule. Should you wish to apply for exemption, please contact Ms Laas at the school for the necessary documents. Please submit applications as soon as possible, but no later than 31 March 2025.
